DELAY IN RESULTS ANNOUNCEMENT

Reference is made to the announcement of Ngai Lik Industrial Holdings Limited (the "Company") dated 9 December 2008 in respect of holding a board meeting to approve the interim results of the Company and its subsidiaries (collectively the "Group") for the six months ended 30 September 2008 and their publication (the "Board Meeting").

The Board of Directors of the Company announces that the Board Meeting has been, as originally scheduled, held on Monday, 22 December 2008 to approve the interim results of the Group for the six months ended 30 September 2008. Trading in the shares of the Company on the Stock Exchange will remain suspended pending the release of the Clarification Announcement and the results announcement for the six months ended 30 September 2008.
